

It is with a heavy heart that I report the passing of my brother, Jerry L. Hall, age 78, of Sarasota, Florida, on August 24, 2025, following a medical emergency. Born in Montpelier, VT, Jerry was the son of Guy U. Hall and Ruth E. Olsen Hall. Jerry was a Balboa High School (Canal Zone, Panama) Class of '65 graduate. He went to Canal Zone College and pursued employment with the Panama Canal Commission as an Electrician Apprentice. Jerry was then called to serve his country

and completed 1 ½ tours in Vietnam as a helicopter pilot.

Following service, Jerry returned to Panama where he met his wife, Caroline, in 1970. They briefly moved to FL but quickly returned home to the Canal Zone. Jerry went on to enjoy his career as a Marine Controller for the Panama Canal Commission until 1999 when his family relocated to Sarasota. In the Canal Zone, both Jerry and Caroline were known for their active involvement in productions for

the Ancon Theatre Guild, United Way, and Surfside Theatre. Jerry was very proud of his hand-built boat, "Little Chap." He loved photography, traveling to Italy, return trips to Panama, and being a supportive member of the Gulf Coast Italian Culture Society (GCICS).

Jerry was predeceased by his wife, Caroline Lambert Statler Hall (2019), and son, Garrett O. Hall (2005). He is survived by his sister, Sandra Hall-Brown (Sandy-BHS Class of '71) of Bethlehem, PA; nephew, Justin A. Brown and family of Palmerton, PA; his partner of 5 years, Elizabeth (Beth) Rose of Sarasota; and his loving dog, Nove. Nove now resides with Beth.

Jerry and Beth described their relationship as their "Chapter 2". Beth expresses that "Jerry is her kind, gentle, non-judgmental man" (and I, as his sister, concur). For me, Jerry is the best brother one could have. He is, and always will be, my "Rock."

Jerry and Caroline were in turned at Sarasota National Cemetery on October 21, 2025.

The Ghosts of Rome (The Rome Escape Line Trilogy - 2) Joseph O'Connor Europa Edition, 2025

In 1943, a Resistance group known as The Choir hides refugees and helps Allied soldiers escape from Nazi-occupied Rome via a secret route known as the Escape Line. Their headquarters are in the Vatican where an American airman falls wounded from his plane and finds The Choir, only to plunge it into deeper danger...

The Escape Line's collapse would leave thousands stranded. Monsignor Hugh O'Flaherty, its architect and the acknowledged leader of The Choir, broods inside the Vatican, daunted by the perils of keeping his Roman underground railroad functioning. Meanwhile, SS Commander Paul Hauptmann has been tasked with

destroying the entire operation, and the price of failure is high—his wife and children are under Gestapo lock-and-key in Berlin. Into this thrilling melee steps Contessa Giovanna Landini, a reckless, audacious member of the Italian Resistance who has the nerve to challenge Hauptmann's authority.

Beautifully written and expertly crafted, *The Ghosts of Rome* is a historical suspense novel bursting with action, atmosphere, and unforgettable characters by one of contemporary fiction's most acclaimed writers. 10/8/25: WINE TASTING AT TOTAL WINE

On October 8, 2025, in an inviting classroom setting surrounded by wines and maps of wine-making countries and regions, John Jester of Total Wine led nineteen members and guests of GCICS on an imaginary tour of the famous vineyards of Italy.

The event, spear-headed by Phillip Gordon of the program committee, included a charcuterie board featuring cured meats, a variety of cheeses, grapes, crackers and olives. Two members of the program committee provided the sweets.

John explained the color, textures, and aromas of the wines as well as vineyard climates as we sipped eight different Italian wines, two white and six reds. We learned what temperatures the wines are best served at and the strict certification process Italy imposes on the wine makers. His explanation of the difference between light, medium-bodied, and full-bodied wines made it all crystal clear. "Think of milk," he said, "light would be skim milk,

medium would be 2%, and full would be whole milk!"

The line-up included Tesoro della Regina Prosecco from Veneto: Armani Pinot Colle 2023 Grigio Ara from Valdadige; Terre Darrigo Etna Rosso DOC 2023 from Etna. Sicily; Barba Montepulciano d'Abruzzo Yang 2022 from Abruzzo; Tenuta di Renieri Chianti Cls Rsva 2021 from Tuscany; Tesoro della Regina Amarone from Veneto; Casalino Brunello di Montalcino 2019 from Brunello di Montalcino; and La Sacrestia Barolo 2019 from Piedmont.

Each table had its own bucket where we could pour wine we didn't want to finish. So no one needed to drink more than they wanted to drink!

Along with the tasting and the learning, we had a fun and social evening as we got breaks between tastings to get more food and to chat with each other
